The activities covered include administration, bushwalking, track and hut construction and maintenance, canyoning, liloing, alpine walking (summer & winter), canoeing / kayaking, boating / rafting, swimming, cycling, rock scurrying and use of hand-held ropes as part of a bushwalk, snow skiing, abseiling, caving, orienteering / rogaining, leader training and other related instructions.
For those aged under 85 and not entitled to sick leave, the personal accident benefit is 80% of lost earnings from week 2 for up to 52 weeks, capped at \$700/week, or \$50,000 if you succumb.
